**CRITERIA AND NOMINATION FORM**



CRITERIA

1. Nominee shall be a current member of the Maine Fire Chiefs' Association (for three years) or recently approved life member (within the last 12 months).
2. Nominee shall have at least three years experience as a Fire Chief.
3. Nominee can be a past Award recipient.
4. Nominee shall be actively involved in, but not limited to, the following:
  - a. Fire prevention education on at least a local level
  - b. Training and safety improvement with their department
  - c. Local community involvement (non-fire service)
  - d. Serving on Maine Fire Chiefs' Association committees or other fire related committees
  - e. Assisting with legislative issues
  - f. Attending the MFCA Annual Conference
  - g. Regional Fire Service Organizations
  - h. County Fire Service Organizations
  - i. State Fire Service Organizations
  - j. National Fire Service Organization Membership
5. Nominee shall be recognized as a leader in the Fire Service by their peers.
6. Nominee shall emphasize leadership, innovation, professional development and integrity, service to the public and contributions to the fire service as a whole.

PROCEDURES

1. Nominations shall be accepted from any municipal official or any fire related local, regional, county, state, national organization, or any MFCA member can nominate another member.
2. Nominations shall be accompanied by supporting documents.
3. The selection committee shall be appointed by the Executive Director of the Maine Fire Chiefs' Association.
  - Two Past-Presidents of M.F.C.A.
  - Two past recipients
  - One municipal official (i.e., Mayor, Councilperson, Selectperson, etc.) from the previous Year's recipient community or other available municipal official
4. Deadline for nominations is August 20, 2018
